# Jesus, His True Story and the Law of Reincarnation

Jesus' Real Existence is True

There exists no other biography of Jesus, the super great leader, than the New Testament. But it was written about 2,000 years ago, and contains some apparently unbelievable descriptions. Of course, it is free for anyone to believe them all, but as an ardent nonfiction researcher, I cannot accept the whole story without questioning, as parts of its contents are a little doubtful.

For instance, there is information about Judas Iscariot from a reliable source, that is contrary to the corresponding description in the Bible. According to the information, in truth Judas did not betray Jesus, but tried to help Him. Knowing about the approaching danger to Jesus, Judas, whose role as an accountant was doing every financial duty for Jesus and His disciples, by himself went to a subordinate of the High Priest Caiaphas, and in offering a big sum of money asked him to help Jesus. But the subordinate ran away with the money, so the intention of Judas did not reach Caiaphas. Then after realizing the failure in the bribery plan, he sorrowfully hung himself from a branch of an elderberry tree. As a matter of fact, this is a story revealed to Mrs. Alice B. Pomeroy by George Adamski.

The New Testament of course was not

written by Jesus, but has been said that it had been written by his disciples. And the nucleus of it is the Gospels written by Matthew, Mark, Luke, and John. The four of them are very much alike in their contents, but are not completely identical. Therefore, some scholars think that there must have been an original book written by someone, then later the other people wrote theirs in the light of the original. And many Bible researchers say that Matthew, the first book of the Gospel. was not written by Matthew himself, but by an enthusiastic adherent of Jeseus who was a Jew and who lived in or around Syria, so that some of the descriptions in the book of Matthew might have been exaggerated or created for a certain purpose.

However, it is clear that Jesus was not a fictitious character, but a person who really lived on Earth. I confirmed it from a great study about Jesus done by Mr. Shigeru Sakakibara, one of the greatest Japanese reserchers on the life of Jesus, who has been in Jerusalem for many years, and with whom I have talked frankly in person when I visited the Holy Land three times in the past. And of course, in "Inside The Space Ships", our George Adamski tells us that Jesus was a person who came to Earth from another planet through reincarnation. Moreover, there are many historical facts and legendary stories

regarding Jesus which are reliable enough. In the final analysis, there is no doubt about the existence of Jesus.

Jesus' real name in Hebrew was Jehoshua, which later was transliterated into Greek as Iesous. Later, in his thirties, he came to be known as "The King of the Jews", but soon was hated by his Jewish fellowmen, and then finally was arrested and crucified at Golgotha by Roman soldiers. How He had lived from the time of his birth until the time of his public mission and dymamic activity is a mystery. And while there are many seemingly exaggerated or created descriptions in his only one biography, the New Testament, if you carefully research the historical remains in Jerusalem that relate to the time of Jesus, you can trace the series of happenings in the Bible: the subordinates of the High Priest arrested Jesus just after he had finished praying at Gethsemane, took him across Kidron Brook to the house of Caiaphas, which was just on the left side of the top of the stone steps; there he was prisoned for one night, and then the next day he was taken to Pilate, the Roman Governor, and the governor finally had to decide on the crucifixion of Jesus, as he was being pressed by the crowd's demand to crucify. From the remains and sites in Jerusalem today, and the story in the Bible, you can see that these events must have actually happened. Then you will be convinced that Jesus did really exist as a person.

The stone steps I just mentioned, which were excavated rather recently, are especially precious remains because Jesus had touched them by his own feet. But it is sad to say that when I visited there last time, many of the stones were gone, because some heartless people had taken them away to use as materials for their house construction.

# History of the Mysterious Holy Shroud

As one of the most important remains which proves Jesus' existence, there is a sheet of cloth, called the "Holy Shroud", which is said to have wrapped Jesus' dead body just after the Crucifixion. It is now stored in Savoy family's Cappela Santa Sindone (Cappela means chapel, Santa Sindone means Holy Shroud, in Italian) in Torino, Italy. Matthew (27:57-61) says that a rich man

named Joseph from Arimathea brought a new linen sheet and wrapped Jesus with it, placed him in a newly dug tomb, and then after rolling a large stone across the entrance to the tomb, he went away. Since there are almost the same descriptions in Mark, Luke, and John, too, this incident must be a true story. And the Holy Shroud has been the best candidate for the historical story of the linen sheet.

Let me talk about the history of this Holy Shroud. Just after 30 A. D., a person brought in a large sheet of cloth to Abgar V, the King of Edessa (currently named Urfa, eastern Turkey), saying, "a mysterious portrait is painted on this sheet. It might be Jesus'," and it was the first appearance of this sheet in the history.

The King of Edessa was a great believer in Jesus, since he had miraculously recovered from a critical disease through his faith in Jesus' teachings. But his son, who succeeded the throne in 57 A. D., hated Jesus' teachings and persecuted early Christians, so someone hid the sheet inside a hole dug in the castle wall. For about 500 years afterwards no one had seen it, and only the rumor remained.

But in 525, a big flood destroyed the whole town of Edessa, and during the following reconstruction work of the ruins, the sheet was found buried in the castle wall. And it soon became an object of worship by people, because they thought the picture was a figure of Jesus painted by someone who had seen Him. But since this picture was like a black and white negative film, it was hard to define features of the figure clearly.

In 944, this sheet was moved from Edessa to Constantinople (currently called Istambul, Turkey), and was stored there until 1204 as the record says. Then following 146 years of a long blank record, in 1350 it was owned by Geoffrey de Charny in France. And in those days of the 1350's for the first time in the history this sheet was called the "Holy Shroud". Later the Holy Shroud was owned by de Charny's granddaughter, Margaret, and then she presented it to the Prince of Savoy. Savoy had been a renowned royal family in Italy, established in the 11th century by Umberto I, and lasting until 1946.

On the night of Dec. 4, 1532, there occurred a fire and it burned a small portion of the Shroud. That accident made the Savoy family decide to move the Shroud to a safer place, and then finally in 1578 they moved it into their chapel in Torino, which was standing next to the Cathedral of John the Baptist.

Since then the sheet remained stored there, being called "the Holy Shroud of Torino", under the administration of the archbishop of Torino. Later Umberto II donated it by his last will to the Curia Romana. And so now it is owned by the Vatican.

# Heated Arguments in the Scientific World

This sheet of cloth, 1. I meters in width, 4. 4 meters in length, looks very old and the color has been faded into yellowish tone, but is still in a good enough condition to be examined. When it is fully unrolled, you can see on both sides lengthwise, two rows of triangular patterns are running, and in between a man's two figures, one is a front figure, the other is a back figure; both figures are attached at the top of the heads in the center of the sheet, both hands of the front figure are crossing at the underbelly.

In 1898, a dramatic discovery was made by Secondo Pia, a lawyer and photographer in Italy. He got permission to photograph the sheet for the first time in the history. And when he developed the dry plate and had the negative picture of the front figure, there he saw a face of extreme solemnity!

After all, the figure on the Shroud was like a usual black and white negative picture, so when it was photographed and developed into a negative picture, it became like a positive black and white picture, which showed much clearer image of the face and the body.

This discovery created a great sensation in the Christian world, because the figure which had been thought to be a painting made by some artist, suddenly became to be considered as probably a holy trace of Jesus himself. And many scientists have eagerly studied this sheet since then, and expressed their various opinions, some positive, some negative.

One of the greatest mysteries about this sheet is how the figure was printed. If you put paint on a man's face and wrap it with a sheet of cloth, the printed face on the sheet will show a much broader and flatter face than the actual one. But the face printed on the Holy

Shroud shows a very three-dimensional image like a photograph taken from the front.

# Who is the man on the Holy Shroud?

Scientists have estimated, from their studies on the Shroud, the man printed there had been about 1.76 meters tall, around 30 years old, weighing about 79 kilograms, with a mustache and a beard. It reveals that the man had a fairly big and tough constitution, which is far different from the slender, weak-looking body of Jesus carved or drawn in our churches. But I believe Jesus must have had a strong, muscular body because he carried on such a dynamic missionary activity leading so many people through those various disturbances. He also must have needed strong vocal cords and abdominal muscle, because he probably had to speak in a very loud voice to the large group of people in the age when there was no microphone. He must have been a stalwart individual with strong leadership.

The other finding of the scientific inspections of the Holy Shroud are as follows:

The skin of the head of the man is torn and there are bloodstains on the forehead and on the back of the head. There are 12 incisions probably made by some sharp-edged tool. The nose is broken, and both eyelids are torn and swollen; these imply he was badly hit. there are some incisions also on both cheeks.

There are numerous scars on the torso, probably caused by whippings. They imply that two men standing on both sides of the man of the figure, (one is fairly taller than the other), whipped him one after another.

There are bad abrasions on the shoulders probably caused by an act of carrying some heavy thing. In those days in Jerusalem, a person who had been sentenced to death by crucifixion was forced to carry the crossbar of the cross (the post had been set on the execution ground beforehand), which is thought to have weighed around 40 kilograms.

There are abrasions on the knees, too, which imply the man tripped and fell badly probably on the way to the execution ground carrying the heavy crossbar.

There is a large open wound on the right flank between 5th rib and 6th rib, and around there is seen a big stain of blood and other colorless details. Also it is found that some kind of coins were inserted into both eyes. That was probably following a Jewish custom that they inserted coins or thin pieces of china into a dead man's eyes, in the purpose of preventing cadaveric stiffening.

There is no trace of washing the body, and that's why there remain bloodstains. There is no important finding about the blood itself, though.

These are the findings about the Holy Shroud made by scientists by October 1978. By that time, the radiocarbon (carbon-14) dating had not been attempted.

The radiocarbon dating, developed in 1946 by an American scientist, Willard F. Riby, was spotlighted in the archaeological world toward the Shroud. However Don Davan, one of the members of the Torino Investigation Committee, says that this method could hardly get a completely accurate result, and often different scientists get widely different results from a same sample using this method. And he suggests that it might be better if several scientists individually measure a same sample using this method and take an average of their measurements.

Many scientists had wanted to use this method to date the Holy Shroud since earlier times, but it was in 1988 when the Vatican finally permitted to do it, and sent chips of the sheet to several laboratories in Europe. But the result officially announced was that the Holy Shroud had been made in the 14th century!

Then who in the world is this man?

# Saw a Reflection of Jesus in a Mother Ship

Now we need Dr. Makoto Akiyama (32) to join our discussion. He is a famous contactee in Japan, and a good friend of mine.

In the early afternoon of June 5, this year, in a tea saloon located in the middle of Nishi-Shinjuku skyscrapers in Tokyo, Dr. Akiyama talks to me sincerely and enthusiastically as usual.

"I undertstand from the space people's information that Jesus was a rather small man, below the average height. But he got a strong, muscular body, and the face was rather slender, though. His mission was to change the direction in which the whole

world was moving in the era of strong authoritarianism, where you have to have a fairly strong body to survive. And he certainly had wonderful abilities in various fields. We may say that he was an almighty person.

For a certain period of time in his life, he was out of the history. And that was the period of his journey to the East, when he visited certain places and contacted with people who had strong mind power. There he discussed with them about in which direction the whole world was going to move in the future and so forth, then went back to his country to start carrying on the activities in a way based on the space people's program."-(cosmic principles)

"Where in the East did he go?" I asked.

"Well, basically three places. Tibet is certain, then maybe around Thailand. And the other one is Egypt, where he stayed especially long. Even in those days there were contactees with space people all over the world, so one of his purposes of the journey might have been to meet some of the contactees and from the discussion with them confirm his mission.

And I believe that to develop or improve his various abilities was one of the purposes of the Journey as well. Jesus was a person who could foresee what kind of things would happen in certain areas in the world, and could know, to avoid the worst results from them, what kind of activities would be the best for him to take. He went back to his own country after he had completely mastered such abilities.

And finally he decided to be crucified. It had much to do with people's unconscious mind power. When the world needs a great change in frequencies desperately, a negative part of collective karma of the people is coming out all at once like pus, and it usually causes a series of great natural disasters. And those days were the days that the karmic distortion of the people was at the crisis and had to be corrected, so Jesus tried to carry all the distorted part of the karma himself to stop the disasters; otherwise numberless people would be killed by the nature's power. To prevent the disaster occurring was his main mission, and his basic purpose to have come here. And when he died, the frequencies of Earth changed, then he resurrected by the help of spacepeople."

"Matthew says that." I asked, "after the Sabbath, on the Sunday early morning, when Mary Magdalene and the other Mary went to see Jesus' tomb, suddenly there occured a great earthquake and an angel of the Lord came down from heaven, then he rolled the stone away, and his appearance was like lightning and his clothes were white as snow. I think the angel Matthew mentioned was a spaceman, and he revived Jesus using some kind of special technique. Am I right?"

"Certainly," Dr. Akiyama replied," spacepeople were very much involved in the Resurrection. They gave Jesus a very strong power at that time. And that was very unusual. In the whole history of Earth, I think that was the only time they used unusual. In the whole history of Earth, I think that was the only time they used their physical power directly for an individual."

According to George Adamski, Jesus was not completely dead after the crucifixion but was in a state of suspended animation.

Then I asked.

"Well, if the man printed on the Holy Shroud was Jesus, from the findings of the inspection of the Shroud, it is reasonable to take that he must have been a man with a rather large frame. Wasn't he?"

"According to spacepeople," Dr. Akiyama said, "he was rather a short person although he had wide shoulders and strong muscles, with a slender and long face. Well, the image on the Holy Shroud might have been enlarged by an oozing effect, so that if you measure the image, it may show that the man was a rather tall and big person.

To tell the truth, they (spacepeople) have shown me once a reflection of living Jesus while I was in their mothership. It was a little blurred picture projected on a rounded screen, and was not a complete movie picture but was moving like a slowly projected timelapse film, so the movement was not smooth. And the color was faint. But I could clearly see," he raised his voice, "the same face there as the one on the Holy Shroud. There I could also see a scene when Jesus was waving his hand, and his fingers were long and knuckled."

"So, was it a reflection which had been shot in some way or the other by the spacepeople while Jesus had been still alive?" I asked. "Yes, I think so. They preserve various records about all the earthlings who have cooperated with them, in a system like a micro floppy disk very much in detail, such as the individual's behavioral pattern, genetic pattern, cell divisional pattern, etc.

But I have not been told about how Jesus had been reborn later and what kind of agreement on his mission had been done between the spacepeople and him while he had been alive as Jesus. This is a matter that is still going on. Especially in the Christian world, how the Christianity should be, or what Jesus really meant to teach us is a really important issue which even involves politics."

Dr. Akiyama kept talking a lot more about meaningful facts regarding Jesus which had influenced this world for these 2000 years, but here we don't have space to introduce them.

As for the result of the carbon dating on the Holy Shroud, that it was made in 14th century, Dr. Akiyama says that the Vatican seems to have released the false information to avoid some probable troubles in the Catholic world.

### Adamski was John in His Past Life

In Inside the Space Ships, when answering Adamski's question, "about these people from other planets who are living amongst us... has that been going on for long?", a lady from another planet answers this way.

"Since time immemorial! Or at least for the past two thousand years. After the crucifixion of Jesus, who was sent to be incarnated on your world to help your people, as had others before him, we decided to carry on our mission in a way less perilous to those concerned than actual birth on your planet."

She states clearly that Jesus came here through reincarnation. But there is no description in the book about from where he did come here.

However, years ago, I first got a information from a group in California that the Venusian who had met George Adamski at Desert Center in 1952 had been reincarnated Jesus. Then later from Mrs. Alice Pomeroy, who was one of Adamski's closest coworkers, I heard the same story.

George Adamski furthermore revealed to a few close people that when Jesus had been crucified at Golgotha, he (Adamski) had been there as John. Mary Magdalene and the other woman are mentioned in the Bible who were at the site to see Jesus' last moment, but there is no name of John in any book in the Gospel. That means George Adamski remembered the scene when he had been there as John. It is known that he was a man with strong supernatural power and remembered his experience for past 5000 years. According to Mrs. Alice Wells, he also had fantastic ability of telepathy, seeing distant places, and seeing other people's aura and past lives, and would evaluate attendants to his regualar seminar by seeing their auras and past lives.

# The Magnificent Portrait of Jesus

After all, the meeting at Desert Center was a reunion of the two men after the lapse of 2000 years. Then one time, probably after the meeting, George Adamski painted an oil portrait of Jesus by seeing through his past life. In autumn of 1975 when I visited Alice Wells at her home in Vista, she told me that he had painted it according to his mental picture of Jesus which had appeared with a rectangular frame like a window frame. I asked her where the portrait was. It was in Maria's house in Mexico City, she replied.

Two years later, I had a chance to visit Mrs. Maria Cristina de Rueda during a trip to Mexico. She was an enthusiastic adherent of Adamski. Adamski trusted her a lot and would visit her and stay at her home once in a while as in the Christmas season. Her husband was a very rich man doing real estate business, and their house was literally a mansion like a castle. The hall on the first floor was unbelievably huge surrounded with so many rooms. Maria led me through a spiral staircase up to the second floor and to a room, and many rooms were there as well. Then there it was! My eyes fastened on a life-size picture hanging on the wall. Just magnificent! Restraining the explosion of my heart, I photographed the portrait with the Nikon F2 which I carried.

It's been said that Adamski had been talented in painting, and that portrait of Jesus was a sure evidence of it. It was a wonderfully well painted picture, although the lower part of the body was not so carefully painted (he

might have concentrated himself on painting the face).

Several years later when Mrs. Maria christina de Rueda passed away, the portrait was taken off the wall, put in her coffin, and burned with her body at her will.

Now, thinking that probably I am the only Japanese who has been privileged to see the portrait firsthand, not only do I feel honored for it, but I can't stop feeling humble sensing an existence of a mysterious karma.

### The Law of Reincarnation

George Adamski stated that the phenomenon called reincarnation certainly existed. This is a subject which is now studied seriously by many people in various fields. In India, some children who had memories of their past lives testified to the existence of this phenomenon. Some day in the future, the whole system will be resolved scientifically.

But what they call the "spiritual world" does not exist. This was what George Adamski strongly pointed out. And Dr. Makoto Akiyama stated same thing as one of the informations from spacepeople.

The essential self of a man moves into a newborn baby's body in three seconds on an average after his bodily death - not at the moment the baby is conceived, but at the moment the baby is born. Therefore a man's life is not only once. He experiences innumerable lives through reincarnations, and usually he spends many lives on Earth, some lives as a white, the other lives as a colored, some lives as a male, the other lives as a female, one after another in various countries. And if he gets enough lessons here, then he will be reincarnated next on some other more improved planet. It's like a graduation from a school. If he does not learn enough, he can't graduate and has to remain in the same school again. The story that the Venusian whom Adams-



# Q60. Are the Masters you mention in INSIDE THE SPACE SHIPS connected in any way the ones certain teachings tell us have control over the destinies of Earth?

A: Because it has been so misunderstood and misinterpreted by students of certain philosophies, I have often regretted my use of the word "Master" in referring to those wise ones whom I met on the spaceships. If I am to abide by the instructions of the great teacher, Jesus the Christ (Matt. 23:8-10), I will have to disagree with all such teachings. To my knowledge, irrespective of what is being so widely taught by some of our present-day schools, no man on Earth has attained the consciousness of Christhood to the place of Mastery.

In my feference to these wise men of other planets, who have grown so far beyond any Earthling in universal knowledge, I used term "Master" as defined by Webster. Quote: "A man eminently or perfectly skilled in any occupation, art or science" Unquote. While these men denied perfection, their understanding of the Universal Laws so advanced over mine, I naturally thought of them as masters in this respect.

They have a knowledge of the working of their bodies, of the power of thought, and a control over their minds that would be impossible for us to emulate, They have perceived their purpose for being their relationship to the Cosmos, and the unity of all contained therein. With this understanding has come a humbleness and compassion such as we cannot conceive. For as one grows in the Universal ways of Life, he is able to see the cause behind all acts; and he then develops compassion for all.

Such a one, seeing the cause, also sees the results of acts as yet uncommitted; for the blueprint has been laid. This enables him to discuss conditions with wisdom and advise without personality, in the hope of offering a solution before the acts are consummated. It

was in this manner that the wise ones to whom I referred as "Masters" conditions on our planet, and explained the history of Earth's people which has led to our present state.

During these talks, they used the illustration of the peoples on other worlds who had changed their pattern and erected their civilization on peace and happiness, with understanding as the foundation for their daily living. They pointed out that the history of these people has been one of construction... While ours has been destruction. Yet at no time was there the slightest indication of condemnation or judgment in their attitude. These wise ones command the deepest respect and affection from all interplanetarians.

But again, let me make it clear. They are normal, physical, human beings. No mystery enshrouds them. They live and move amongst the people as do other men. According to our conception of time, they are very aged; but I repeat, they do not claim mastery of any kind. They admit they have attained a higher understanding than many of their fellowmen; but they always add, through the Laws of the Infinite, we all will eventually grow to their present knowledge; while they, in turn, advance to still higher understanding.

As with all men, in time they will lay down their present bodies and take up new ones. We call this transition death, and most of us look upon it with fear and dread; while they view it only as the moving from one house into a newer and finer home. But as with their present bodies, their new ones will be a material form. For it is only through manifestation that the Life Force of the Divine Creator can express. Therefore, our concept of mastery meaning growing beyond the need of a human form, is but one more example of our misinterpretation of the Laws of Life.

Man's inability to recognize his potential has been the cause behind the perversion of our present teachings. He stands in awe of that which his comprehension cannot readily catalogue with fact already familiar to him, and these "unknowns" he relegates to a realm of his own invention... the mystical. And how we love our mystical! In ancient times many took advantage of this human frailty, and by cloaking the simple Universal Truths in mystery, exalted themselves to become rulers of the people. Down through the ages, others with little understanding have added their personal interpretations; until the kernel of Truth has all but been lost.

But the fundamental Laws of the Cosmos are simple and few. As we grow in understanding we become able to recognize them by their very simplicity... then discard the chaff.

Q61. In reply to the letter I wrote to my representative in Washington regarding Mr. Straith's letter I was told that there is no Mr. Straith in the State Department, and never has been. Also that there is no Cultural Exchange Committee. Can you explain?

A: Before making Mr. Straith's letter public, in accordance with my interpretation of its third paragraph wherein I was encouraged to communicate to "our American public" what I believed should be told, I made a thorough investigation of the authenticity of the letter. At that time I was assured that Mr. Straith was an employee of the State Department. whose work was of such a nature that his name did not appear on any of the published lists of that Department. However, obviously because of the pressure brought to bear upon my informant since I released Mr. Straith's letter, this statement has been retracted. But before the letter was released, when this pressure was not being exerted, the real facts were stated without fear.

The denial of the existence of the Cultural Exchange Committee is particularly puzzling, since the services it performs are internationally known. It is through this department that representatives of United States obtain their visas for goodwill tours abroad; and similar groups from other countries make their arrangements to visit America. It stands for exactly what the name implies—cultural exchange between nations. The main purpose of this body is to bring about a better understanding between the peoples of the world through a friendly exchange of representative citizens from all walks of life.

The Culture Exchange program has been widely publicized on the air and through the press. For example, news papers in both England and United States (how many other countries I do not know) carried articles about Bob Hope returning from London to New York so he could get his visa through Cultural Exchange for his recent visit to Russia. I have clippings of this in my files, and the May-June 1958 issue of "Flying Saucer Review" referred to similar reports published in the London "Times."

The formation of any "program" is usually handled by a group of individuals. In the United States it is customary to refer to these groups as a "committee." Mr. Straith identified himself with the Cultural Exchange Committee.

I recently received word from a correspondent in Washington, D. C., that the letterhead upon which Mr. Straith wrote to me was turned out by "tens of thousands" with the Seal of State IMPRESSED on the blank paper. This, I do not believe!

Admittedly, when the Seal is **printed** on the letterhead, it would be done as one printing operation, with the imprint of the Seal in the same color ink as the letterhead—which, in all communications I have received where the Seal was printed, has been blue. But the letter I received from Mr. Straith had the Seal **impressed** in the paper, **and it was not colored**. The State Department representative who visited me in regard to this matter, admitted that the Seal was **never impressed** upon blank paper. Always bear in mind, the highest official documents of our land carry the Seal of State... **impressed**!

We must remember that it is the presence of

the impressed Seal of State that endows a document with official authority; and this authority is recognized not only in our country, but in every nation on Earth. So if our government were to impress this Seal on blank paper by the "tens of thosands," then permit the indiscriminate use of these letterheads, the impression of our sacred Seal of State would do longer carry weight as an official sanction. This would be a serious matter which could influence our intercourse with other nations, and one that should receive attention from our top government authorities. If anyone is deliberately misusing our Seal of State, he should by located and exposed.

Therefore, if one of our recognized government officials will write to me that our Seal of State has lost its intrinsic value by allowing these letterheads with it **impressed** to be indiscriminately used by anyone who wants to use them, I shall photostat his letter and airmail it to every person to whom I sent a photostat of Mr. Straith's letter. Also, I will reprint his letter in my next issue of Questions and Answers.

# Q62. Why are the governments so hesitant about informing the public concerning the space visitations?

A: In the beginning I believe this was due to a sincere solicitude on the part of our leaders, because they feared the people would panic if they were told officially that they were being watched by unknown people from outer space, against whom we had no adequate protection should they prove hostile. However, if you will review the published Air Force reports during the past ten years, you will find ample proof that they tried to tell the people the truth. You will notice that many times they have admitted the reality of space craft (UFOs), but as reports were received indicating a state of panic rising amongst the people, the officials were forced to retract these admissions. So actually, it has been the public that is responsible for those vacillating reports. Remember, those who are terrified are the ones who will make the telephone calls, and write the letters to the officials; but how many of you who sincerely believe in the reality of the space people coming in friendship have ever bothered to convey your beliefs to these same officials?

We have many examples of the prevalence of this public panic, our sonic booms being one familiar to us all. Notice how every time a news report is made regarding this phenomenon, it is always accompanied by the statement that the police department, the fire department, the newspapers, etc., were flooded with calls. Our officials must depend upon such reports as an indication of the attitude of the general public. Therefore, we have only ourselves to blame.

On the other hand if enough steady citizens are interested, and make their wishes known to the authorities so our goverment can feel assured that those who would panic will be outnumbered in sufficient proportions to insure the safe release of facts, I believe this information will be forthcoming in a reasonably short time. But this can be accomplished only through the persistent and concerted efforts fo those who are willing to accept space visitations calmly.

# Q63. Why haven't you defended yourself against some of your critics?

A: Any man whose activities place him before the public, must be prepared for the criticism of those who do not agree with him. There also will be those who will go so far as to endeavor to prove that he is deliberately trying to pervert facts, and thereby take advantage of innocent people. I am aware of this attitude on the part of some, but I know that truth needs no defense. Given time, truth always proves itself; because it is based on the firm foundation of reality.

Every man has but twenty-four hours in a day; and he may spend his time as he will. I consider my time too valuable to be wasted in controversies which, once started, must be continued—and seldom accomplish anything beneficial. Had I devoted these past years to replying to my critics, it would have been impossible for me to have read and answered the volumes of mail coming to me from every part of the world, to say nothing of the other works I have succeeded in doing.

My choice lies in constructive efforts for the betterment of life on this planet.



# GAP-Japan 1992 General Assembly

Gap-Japan's annual general assembly was held under the appellation of "The 40th Anniversary of George Adamski's Contact at Desert Center", at the Kikai Shinko Hall in front of the Tokyo Tower on October 10, 1992. 210 people attended the meeting, most of whom were members of the Japanese GAP supporting Adamski's claims.

This assembly was given in commemoration of Adamski's contact with an extraterrestrial from the planet Venus at "Desert Center", California, on November 20, 1952.

First, Hachiro Kubota, representative of GAP-Japan, gave a lecture entitled "How To Have Cosmic Faith And Courage", on which he talked on the subject of Adamski's cosmic philosophy.

At the end of his talk, under his guidance, all those who were present, practiced cosmic meditation in order to unify their minds and Cosmic Consciousness together.

# JAP-Japan

GAP-Japan was established by Hachiro Kubota in 1961, who had been one of Adamski's international co-workers since 1954.

At present it is the largest UFO-Cosmic Philosophy research group in Asia. Its head office is located in Tokyo and there are 17 branches throughout the country. Its publications are the Japanese edition of "UFO contactee", which is published 4 times a year, as well as the English edition of "UFO contactee" published once every year. The head office and its 17 branches have monthly meeting to conduct studies of UFO affairs and cosmic philosophy. All the branches' research is based on tape recordings and videos made by head office in Tokyo.

All the members of GAP-Japsn are earnest followers of Adamski's claims, and the practice of his cosmic philosophy is based primarily on his books, "Science of Life" and "Telepathy - The Cosmic or Universal Lan-

guage", which are considered the foundation of his teaching.

All his books and speeches, made throughout the world, are translated by Kubota into Japanese, and are published in Tokyo as the "New Adamski Complete Works" by Chuo Art Publishing Co. and it comprises 10 volumes.

Some members have developed their psychic abilities especially in the use of telepathy, clairvoyance, seeing aura, etc. In addition, some members contacted space people from other planets!
